Prior to COVID-19, Pop-Ups made us think Sephora and yoga classes

- During a press conference on Tuesday 6/23, Governor Baker said that of the 17,617 tests conducted over the two-day period, 2.5 percent came back positive for COVID-19
- He noted this rate as being "reasonably consistent" with the statewide numbers.
- As of 6/22, the state's seven-day average positive COVID-19 test rate was 1.9 percent, down 93 percent from mid-April.

Data were collected from 2,126,185 people, and age was available for 2,122,894 (99.8%) people

- The deadline to apply for a PPP loan is fast approaching: June 30.
- For those who have already received a PPP loan, last week the Prioritized Paycheck Protection Program – or P4 – Act was proposed in Congress for businesses still struggling despite already having received a PPP loan.
- The new program would allow small businesses with less than 100 employees to apply for a second loan. (at this time is unclear how likely it is for the P4 Act to become law)

IF YOU HAVEN'T APPLIED THERE IS STILL ONE MORE DAY TO DO SO AND IF YOU NEED MORE "FORGIVABLE" FUNDING, YOU MAY BE IN LUCK. . .

- ► The bill extends the application deadline for initial PPP loans from June 30 to Dec. 30 or longer, at the discretion of the Small Business Administration (SBA)**
- Companies that already received PPP loans, those with 100 employees or fewer including sole proprietorships and self-employed individuals, would be eligible for a second loan.
- To participate, businesses already must have expended an initial PPP loan, or be on pace to exhaust the funding, and must demonstrate a revenue loss of 50 percent or more due to the COVID-19 pandemic. Existing PPP funding would be used to make P4 loans**
- The bill also directs SBA to issue guidance to give priority to businesses with 10 employees or fewer in the processing and disbursement of P4 and PPP loans, and requires SBA to request demographic information of P4 and PPP loan recipients. It also would allow P4 recipients maximum flexibility to apply for loan forgiveness as soon as 8 weeks after the loan disbursement.

P4 DETAILS/PROPOSALS OF BILL

If you received funding prior to June 5th, you will have to choose your forgiveness period; either 8 or 24 weeks (nothing in between)

If you received it after June 5th, then you automatically use 24 weeks (in both cases to show that 60% of your money went to payroll)

If the original application was 11 pages and is now 3, I wonder when the next version will come out and how condensed that will be??

Exceptions to the original guidelines should make it difficult NOT to be forgiven

REMEMBER THE MAGIC DATE OF JUNE 5TH FULL TIME EQUIVALENT REDUCTION EXCEPTIONS:

- A good-faith, written offer to rehire an individual who was an employee on February 15, 2020 was rejected by the employee and the Borrower was unable to hire similarly qualified employees for unfilled positions on or before December 31, 2020;
- A good-faith, written offer to restore any reduction in hours, at the same salary or wages was rejected by the employee
- Any employees who (a) were fired for cause, (b) voluntarily resigned, or (c) voluntarily requested and received a reduction of their hours.

- SBA began accepting new Economic Injury Disaster Loan (EIDL) and EIDL Advance applications on June 15 to qualified small businesses and U.S. agricultural businesses.
- The new eligibility for U.S. agricultural businesses is made possible as a result of the latest round of funds appropriated by Congress in response to the COVID-19 pandemic.
- Applicants who have already submitted their applications will continue to be processed on a first-come, first-served basis.
